

Appendix B

AGREEMENT FOR SELECTIVE HOUSING OF DEPOSITORY DOCUMENTS

This AGREEMENT is made retroactive to April 15, 1986 by and between the UM-C Libraries as the Federal Regional Depository Library and the UM-C Law Library.

This agreement is entered into for the purpose of selectively housing in the UM-C Law Library federal documents received by the Regional which are appropriate for the primary interests of the Law Library. The documents are lent indefinitely but remain the property of the U.S. Government Printing Office under the control of the UM-C Law Library.

In pursuance of this Agreement, the UM-C Law Library agrees to:

- 1) Assign the responsibility for carrying out the provisions of this Agreement to the documents librarian in the Law Library.
- 2) Make available all documents free of charge to the general public.
- 3) Lend to the UM-C Libraries any document for a period agreed to at the time of loan execution.
- 4) Maintain all documents in compliance with Title 44, U.S. Code; Instructions to Depository Libraries; Guidelines for the Depository Library Program.
- 5) Inventory, identify, and maintain a public record of the documents housed under this Agreement.
- 6) Retain stamps and notes as supplied by the Regional Library.
- 7) Return to the Regional Library all documents which are no longer considered useful.
- 8) Replace any lost document.

The Regional Library agrees to:

- 1) Transfer and continue to send documents which include, but are not limited to reports and decisions of federal regulatory agencies to the UM-C

Law Library. (Attachment)

- 2) Keep records indicating the location of documents involved in this Agreement.
- 3) Abide by any borrowing Agreement made with the UM-C Law Library.
- 4) Accept all documents upon termination of this Agreement.

Nothing in this agreement should affect the status of the individual depository library.

This Agreement may be terminated by written notice from either party 60 days in advance before all documents are returned to the Regional Library.
