PRINCIPAL CONTENTS.

THE Author attends the King five Months in Prison—Begins his Journal the 10th of August, 1792—Describes that dreadful day—The King informs the Legislative Assembly of the Desertion of the Guards, and of the Danger of his Situation—He is invited to the Assembly—Is sent with his Family to the Tower, and his Authority suspended—The Queen deprived of her female Attendants—Insolent Behaviour of the Municipal Officers to the Royal Family—Head of the Princess Lambelle borne on a Pike before the Temple, while the King and his Family are at Dinner—The populace cry out for the King to appear at the Window—The Mob attempt to rush into the Tower with the Body of the Princess Lambelle, naked and bloody as it had been dragged from the Prison, *de la Force*—The Queen faints at the Sight, and afterwards mingles her tears with those of her Children—Description of the Tower, and the Royal Family's manner of Living—Some account of Santerre, and of *Simon*, the Shoemaker, to whom the Young Prince was afterwards consigned—Insulting and indecent Epithets written on the Walls, and used by the Municipal Officers—Royalty abolished, and a Republic proclaimed before the Temple—The King demands a Supply of Necessaries—Is supplied with Linen, &c. by the English Ambassador's Lady, the Countess of *Sutherland*—Cruel State of Alarm to the Queen and her Family, on the King being removed into the Great Tower—Description of that Prison—Cléry overwhelmed with Grief at his Master's Separation from his Family—The King and Queen again meet and are transported with Joy—Secret manner of receiving Intelligence of Events happening in Paris—The Orders of St. Louis worn by the King, directed to be removed—Extravagant Whims of the Municipal Officers to insult the Royal Family—Having caught cold, the King is visited by his Physician, *M. le Monnier*—Grief of this venerable old Man when he saw his Master—The Royal Family deprived of Knives, Razors, Scissars, &c.—Puts a stop to the little Works which served to divert their Attention—New Decrees of Tyranny—The King put on his Trial Dec. 11th—Tenderly embraces his Family—Is conducted by *Santerre* to the Convention—Complains of being deprived of his Razors, and of his Beard being troublesome—His Majesty's Will which he wrote on Christmas-Day—The Trial ends—The King is condemned—His Reflections on his unfortunate Family—The King refused Knife and Fork at his Meals—He remonstrates—Finel Interview of the King and his Family—Their agonizing Farewel—The last Scene described, when the best of King's was no more.
