- greeting and introductions (Jim Cogswell)
- presentation and overview of Task Force charge (Jim Cogswell)
 - CMS issues that must be addressed by the Task Force:
 - integration with MU Libraries and other applicable UMC web applications (e.g., link resolver software, federated search software)
 - Cascade Server (UMC's purchased CMS) be given serious consideration; we must have good reasons to choose something other than Cascade Server
 - deadline for Task Force recommendation: end of Summer 2006, though this deadline may be too ambitious. Nevertheless at the very least a progress report is due to the Director at that time.
 - identify minimum requirements for a library CMS
 - examine available systems
 - provide for demonstrations of viable systems
 - the Task Force recommendation should not serve only one constituent group in the Libraries
- questions about charge (Task Force members to Jim Cogswell)
 - open source products can be considered? yes
 - potential to hire programmer to support product (in part)? yes
 - funding limit? yes and no – without considering specifics, \$8K – \$10K/year is feasible
 - exclusively a 'web' content management system? yes
 - recommend only a single product? one 'preferred' product with at least one other option to pursue
 - consider both vendor- and locally-hosted products? yes
