## REPORTS:

Book Sale: Wayne: In review of the draft of the revised gift policy on acquiring value gift materials, which should be available shortly for review by staff, the Director officially stated that there would be no more big biennial book sale at the February 26th Library Council meeting.

While the book sale did make money in the short-term, the administration has decided that it is not cost-effective in the long run. The large-scale book sale has been abandoned due to the amount of staff time involved (in both planning and conducting the operation).

A continual, small-scale sale will be held in a portion of Copy Service to be remodeled and open by this summer or fall at the latest. Materials of higher value will be listed for sale by a local member of a national antiquarian society with whom the Libraries already have relations with.

The Director stated that he hoped that MULSA or the board did not interpret this as an attack on MULSA or a purposeful undercutting of our budget. The reality, however, exists that the board must plan for future alternative funding sources. MULSA, being contract labor for the previous Friends of the Libraries Book Sales, would not be the recipient of the proceeds of this new enterprise to dispose of undesired (not unloved) materials.

The title of the current Book sale chair offices will probably need to be renamed to something like Fundraising chair(s). The term should probably also be reconsidered and made yearly instead. If these changes need to be made by the members, these changes will need to voted on prior to the election of officers.

The director did note that he would be willing to meet with the board of members of the board if necessary.
